READING OF THE MINUTES

Motion by Director Anderson to dispense with a reading of the December 16, 2016, committee minutes and approve them as distributed. Second by Director Tweed. Upon voice vote, motion carried.

RED RIVER VALLEY WATER SUPPLY PROJECT UPDATE

The committee reviewed the topics of discussion from the LAWA board meeting held prior to this meeting today.

Director Anderson asked what happened with the quick take authority that was being sought in this legislative session for the Red River Valley Water Supply Project (RRVWSP).

Merri Mooridian, Administrative Officer, Garrison Diversion, said it was taken out of the bill at this time. It was felt that since the RRVWSP is not yet under construction, it may be premature.

Springsted Funding Request -- Ms. Mooridian commented that at the time Ernst & Young was approved as the municipal advisors for the RRVWSP, there was an option included to initiate negotiations with Springsted for the issuance of bonds and any related consultation on an as-needed basis. She asked the committee for a recommendation to the full board authorizing funding in the amount of \$50,000 to work with Springsted on the financial modeling.

Motion by Director Anderson to recommend utilizing Springsted's financial services for the Red River Valley Water Supply Project not to exceed \$50,000 to the full board. Second by Director Kaiser. Upon roll call vote, the following directors voted aye: Anderson, Kaiser, Tweed and Vein. Those voting nay: none. Absent and not voting: Fenstad. Motion carried.

There being no further business to come before the committee, the meeting was adjourned at 1:00 p.m.
